

2018 Miss Phenix City Pageant Local Contract

Please read this document carefully. Contact the director with any questions you may have regarding your understanding of this contract. Include information page at the end of this contract when submitting paperwork!

- I attest that I am a citizen of The United States of America and I meet the requirements to enter the pageant based on ONE of the following. Only ONE of the following is required to meet the pageant requirements.
- A legal resident residing at _____
- or a full-time, registered student in good standing at _____ (High School, College, or University)
- or a full-time employee at _____ (Name of Company), located in _____ (City, Zip).
- I agree to represent the Miss Phenix City Pageant and the Miss Phenix City Pageant Committee with professionalism and will represent their events in a professional manner.
- I understand that I am only allowed to wear my crown in public with my director(s) permission.
- I agree to refer any request for appearances to the director of the Miss Phenix City Pageant. This includes ALL requests made by civic groups, school organizations, other pageant directors, former directors, and other preliminary winners. I understand that any requests to speak with the media (print and electronic) will be forwarded to the pageant staff.
- I understand that failure to make appearances will result in the loss of my title as Miss Phenix City unless the Director excuses me.
- I understand that I am "Miss Phenix City" at all times. I will dress appropriately when in the community and be properly groomed with make-up, proper clothing, and hair and nails properly groomed. I will be "camera-ready" when in the community and will not wear inappropriate clothing or be seen in businesses that leave the impression of poor moral judgment.
- I will be on time for all public appearances and will be appropriately dressed for each appearance. I understand that there is never an excuse for being late to an appearance and will make the necessary arrangements to be on time. I will arrive at the appearance refreshed and will never look tired, bored, or otherwise distracted. I will conduct myself in a manner that will uphold the dignity and honor of the pageant.
- I understand that if I have a boyfriend during my year of service, he is not to show public displays of affection to me under any circumstances while I am making an appearance as Miss Phenix City.
- I understand that a pageant staff member will accompany me to any and all appearances. Approved chaperones include Miss Phenix City Pageant staff members and others that may be designated by the Miss Phenix City director(s).
- If I have a Facebook, MySpace, twitter or any type of social media account, I understand that inappropriate pictures and/or language should be removed in order to uphold the dignity of the pageant. I agree to make the Facebook and social medial profiles available to the director for viewing (in the form of becoming friends on these websites).

- I agree to have all clothing required for the 2018 Miss Alabama Pageant prepared for viewing by the Miss Phenix City Pageant director and staff by the tentative deadline of April 15, 2018. I understand that it is a mandatory requirement.
- I will have all documents, photos, and mandatory requirements of the Miss Alabama Pageant prepared by the deadline set forth by the Miss Alabama Pageant for the 2018 Miss Alabama Pageant.
- I agree that the pageant director/staff shall have final approval of my talent selection, clothing, and all related items for the 2018 Miss Alabama Pageant. (NO EXCEPTIONS!)
- I agree that I will have my platform scrapbook completed for final review by the pageant director/staff one week prior to the deadline set forth by the Miss Alabama Pageant. I also agree that my scrapbook will be prepared with the guidelines set forth by the Miss Alabama Pageant. (NO EXCEPTIONS!)
- I understand that my attendance at the Orientation for Miss Alabama Contests participation in the 2018 Miss Alabama Pageant is mandatory. I also understand that my attendance at the Workshop for the 2018 Miss Alabama Pageant contests is mandatory. The Miss Alabama Pageant will determine these dates as well as other mandatory deadlines. I understand that it is my responsibility to clear any possible conflict from my schedules in order to attend these mandatory meetings of contestants.
- I agree that I will maintain my physical appearance through exercise and diet.
- I agree to participate in practice interview sessions with the director/staff during my year of service.
- I agree to practice my talent on a regular basis. This includes being prepared to entertain at appearances related to the title of Miss Phenix City.
- I understand that it is my responsibility to develop my platform and maintain information related to my platform that will benefit the development and presentation of my platform.
- I agree that I will inform the director/staff of the Miss Phenix City Pageant of my school and work schedule and any changes in my schedule that occur during my year of service. This disclosure includes my work schedule and any changes that occur in that schedule.
- I understand that I am responsible for reporting any conflicts associated with the Miss Phenix City title to the director/staff immediately.
- I agree to maintain a passing Grade Point Average at the high school, college or university I am attending. I will inform the director of my Grade Point Average at the end of each semester/quarter during my year of service.
- I agree that I will exercise complete confidentiality with my director/pageant staff. I will in no way damage the reputation or the integrity of the Miss Phenix City Pageant, pageant staff or others involved in the pageant.
- I agree that if I am selected as Miss Phenix City 2018, I will serve as Miss Phenix City until my successor is selected or appointed.
- I understand that outside "coaching" or "training" is not permitted without prior approval of the director. Any attempt by an outside person and/or company to involve me in "coaching" and or "training" should be reported immediately to the director/staff. This includes selection of competition clothing, interview practice or other related matters. I understand that any coaching or training I am currently received should be reported immediately to the director/staff.

- I agree that once the final decision is made regarding my clothing for the 2018 Miss Alabama Pageant, NO changes may be made without prior approval of the director. This includes non-competition clothing as well as ALL competition clothing. I understand that the wardrobe selections are made for all pre-pageant and post-pageant events.
- I understand that the scholarship money I may receive as Miss Phenix City will be paid directly to the college or university I am attending. I understand that I will be responsible for accepting this scholarship within one year of winning my title. I will submit a letter of acceptance of any scholarship monies with 60 days of the pageant.
- I understand that the following appearances are mandatory and may not be missed. I understand that it is my responsibility to clear my calendar of any potential conflicts in order to attend these functions: Christmas Parade (usually first Saturday in December; 9:00 AM EST tentatively), Miss Alabama's Outstanding Teen Pageant in Sylacauga (March, 2018), Miss Phenix City 2018 workshops and or rehearsals; Interviews with local newspapers and possible radio interviews; 2 Talent performance appearances; 4 Platform appearances; 4 Speaking appearances.
